Christmas TreeBNB is a fun Christmas themed BSC token project that provides a fair, rewarding and fun way to collect crypto assets.

There are too many BSC projects in the space that are offering unfair taxes, stability damaging swap rewards and reflections that cause inflation and ultimately offer no market or price stability.

We offer a Christmas Advent Calendar dApp starting from the 1st of December 2021 that will allow holders to open a door every day, revealing a prize of BNB or gift cards that can be redeemed via our Telegram group.

Each year the prize calendar will be refreshed and new partners and investors will be brought on board to amplify the seasonal activity of the project come each Christmas period.

# **Taxes & Tokenomics**

Our clear and easy to understand tax structure is broken down below as well as the uses for each tax type.

#### Gift Tax

This tax is collected in the contract, then sold for BNB once the number of collected tokens reaches a defined amount. This BNB is used to reward holders and to purchase gift cards for the advent calendar prizes.

## **Marketing Tax**

This tax is collected in the contract, then sold for BNB once the number of collected tokens reaches a defined amount. It is used to fund marketing campaigns, promotions via PPC, influencers, Telegram group shoutouts etc.



When you buy XMASTREE via a swap exchange such as Pancakeswap for example, you will be charged the following tax on the transaction amount:

1% (Marketing) + 1% (Gift Rewards)

#### Sell Tax

When you sell XMASTREE via a swap exchange such as Pancakeswap for example, you will be charged the following tax on the transaction amount:

2% (Marketing) + 8% (Gift Rewards)

#### Transfer Tax

When you transfer XMASTREE from one wallet to another, outside of an exchange, you will be charged the following tax on the transaction amount:

2% (Marketing) + 2% (Gift Rewards)

## **Presale**

We did not conduct any presale for ChristmasTreeBNB – the contract was deployed to the live BSC network, liquidity was added via PancakeSwap then locked for 12 months and marketing was started. This was to ensure that we gave a fair and open launch that anyone could be involved with as soon as they discovered the project.

There was no private group or individuals that had access to purchase XMASTREE tokens before anyone else.

# Liquidity

We supplied 8BNB in liquidity and locked it for 12 months using Team.finance - this can be validated at the following link:

# **Token Distribution**

The contract was deployed and the initial total supply of 100 trillion tokens was distributed in the following way:

Description	Number of tokens	% of total supply

# **Marketing and Promotion**

We have a great suite of marketing tools and professionals available to give ChristmasTreeBNB an appealing visual brand identity as well as serving effective marketing campaigns to gain new followers.

Here are examples of some of the marketing and promotional campaigns we will be running:

### **Smart Contract**

The ChristmasTreeBNB smart contract was written from scratch for our project - no copy and paste from another project.

The smart contract contains basic tokenomic functions such as burn, taxes, tax exemption functions, and functions giving the ability to change tax rates or disable them altogether.

#### **Contract Variables**

The contract stores several variables, here is a description of some of them:

- giftCount
- taxCount
- liqCount

The number of tokens currently collected in the respective tax wallet (gift, tax or liq wallets)

- giftSwapAt
- taxSwapAt
- liqSwapAt

The number of tokens to collect in the respective tax wallet before performing a sell swap to convert the tokens to BNB

- giftTaxS
- taxTaxS
- liqTaxS

The tax rate (in %) for each 3 taxes taken on a SELL transaction

- giftTaxB
- taxTaxB
- liqTaxB

The tax rate (in %) for each 3 taxes taken on a BUY transaction

- giftTaxT
- taxTaxT
- liqTaxT

The tax rate (in %) for each 3 taxes taken on a TRANSFER transaction

#### maxTxPercent

The maximum number of tokens allowed in any transaction as a % of total supply

#### swapOnSell

Enable the function to perform swaps for taxes.

- taxesOnBuy
- taxesOnSell
- taxesOnTran

This determines if taxes are performed on the respective transaction type.

#### **Contract Functions**

The contract has standard functions and the special pens are defined here:

#### addTaxExempt()

Specify a wallet address that will not be charged any taxes for transactions.

#### • change\*()

Various functions with this name pattern allow us to change the values of variables described above (tax rates, tax status, etc)

#### emptyContractWallet()

This function allows us to move tokens stored in the contract wallet into another specified wallet. This is needed because ALL tax tokens are stored in the contract wallet and if the swap function fails there would be no other way to transfer these tokens from the contract wallet.
